







All the screening committee members are hereby instructed to adhere to the following conditions while screening the candidature of applicants (In the University or in the colleges both for contractual, stop gap arrangements, academic arrangements as well as permanent teaching position):

1. **Core subjects of disciplines** (PG and Ph.D.) must be the **same as the subject** advertised by the university.
2. Degrees in **other disciplines** (PG and Ph.D.) must be considered as **"Not Eligible"**.
3. **Equivalent disciplines** for a particular subject to be considered, **"Must Follow"** the latest attached guidelines of NET. (**PAGE 50-52**).
4. **NET** (Where Applicable) **only in the core subject** will be considered. **Not in other subjects.**
5. **UGC NET** Guidelines are attached. Please consult **Table from page 50 to 52.**
