There will be two sections A and B.

2) There will be 9 questions in all.

3) Section A will carry one compulsory question (question no 1) with four sub-parts (consisting of short answer type questions). Each sub-part (short answer type question) will be from each unit and a student will have to attempt all the four sub-parts.

4) Section B will comprise of four long answer type questions (question number 2 to 5); each question

will have an option. Thus, there will be two questions from each unit. In total, there will be eight

questions in the section; two from each unit and a candidate will be asked to attempt four questions.

5) All short answer type questions will carry 31/2 marks each. Thus, question No 1 will carry weightage of 14 marks. Whereas, each question from no 2 to 5 will carry equal marks of 14 marks.

**Note**: There will be internal examinations (Assignments, Tests and Presentations) of 30% marks in each semester. End-semester examination will be of the rest 70% marks in each semester.
