University of Ladakh is the only Trans-Himalayan institute of higher learning and research, therefore, an institute of higher learning of its kind was established as an initiative to promote quality higher education and to be the Premier University of the country, particularly in the UT of Ladakh. It has its courses and research programs specific to the Himalayan, Trans Himalayan, and South and Central Asian region, not ordinarily available in other universities in India.

- 3. WHEREAS CSIR- IICT and UOL have agreed to collaborate in the following areas:
 - To explore research and development opportunities
 - Jointly organising research and publication activities.
 - Jointly organising workshops on Massive Open Online Learning (MOOC) and Information and Communication Technology (ITC).
 - Jointly explore scientific and academic research projects beneficial to both.
 - Exchange of faculty/or staff and students.
 - Organise faculty development programmes.
 - Jointly organising seminars, conferences and academic workshops on topics including of mutual interests.
- 4. CSIR-IICT and UOL agreed to enter into separate agreements on case to case basis, with the scope of work involving terms and conditions, financial arrangements, Intellectual Property Rights and respective responsibilities.
- 5. Whereas this MOU is valid for 03 years from the date of signing. However, MOU may be extended for further period or curtailed with mutual consent.
- 6. Except as hereinbefore provided, any dispute arising out of this MOU, the same shall be referred to the arbitration of two arbitrators one to be appointed by each party to the dispute, and in case of difference of opinion between them to a umpire appointed by the said two arbitrators before entering on the reference, and the decision of such arbitrators or umpire as the case may be shall be final and binding on both. The venue of arbitration shall be such place as may be fixed by such arbitrators or umpire and the arbitration proceedings shall take place under the Indian arbitration Act, 1940 as modified in 1996.
- 7. This MOU has been executed in two originals; one of these has been retained by CSIR-Soldy IICT and the other by UOL
