
MEMORANDUM OF UNDERSTANDING

ABOUT GGSIPU: Guru Gobind Singh Indraprastha University (GGSIPU) is the first university established in 1998 by Govt. of NCT of Delhi under the provisions of Guru Gobind Singh Indraprastha University Act, 1998 read with its Amendment in 1999 The University is recognized by University Grants Commission (UGC), India under section 12B & 2f of UGC Act.

It is a teaching and affiliating University with the explicit objective of facilitating and promoting "studies, research and extension work in emerging areas of higher education with a focus on professional education, for example, Education, Engineering, Technology, Management studies, Medicine, Pharmacy, Nursing, Law, etc. and also to achieve excellence in these and connected fields and other matters connected therewith or incidental thereto." Guru Gobind Singh Indraprastha University is an A++ NAAC Accredited University and is also listed in the top 1500 QS World University Rankings 2024.

About University of Ladakh, UT Ladakh, a statutory body established in 2019 & recognized by UGC under section 12(F). The University of Ladakh is the only Trans-Himalayan Institute of higher learning and research. The University has its headquarters both in Leh and Kargil and has Six Degree colleges as constituent colleges.

This Memorandum of Understanding (hereinafter called as the 'MOU') is signed on 04 day of April 2024 at New Delhi, India.













By and Between:

Guru Gobind Singh Indraprastha University, Sector 16 C, Dwarka New Delhi – 110078, The First Party, having the main campus in Dwarka New Delhi, India, (hereafter referred to as "GGSIPU") which expression, unless repugnant to the text or context thereof shall include it successors, affiliates and permitted assigns, of the First Party.

AND

UNIVERSITY OF LADAKH, Administrative Office, Melongthang, Leh Ladakh-194101, The Second Party (hereafter referred to as "UOL") which expression, unless repugnant to the text or context thereof shall include its successors and permitted assigns of the Second Party.

And have hereby decided that both parties would adhere to the following responsibility charter listed below:

Section- 1.0: MOU Signatories

The Signatories of the MOU will be GGSIPU and UoL

Section 2.0: Objectives and Scope:

The scope of the Memorandum of Understanding is as under –

- a) To mutually plan and conduct lectures/ workshops/ symposia/ conferences/ other similar events in mutually agreeable areas at the state/national/international level.
- b) To undertake field visits, training, internhips, placements, etc. for sstudents.
- c) To undertake joint study/research projects on mututally agreeable terms
- d) To take collaborative measures on developing MOOCs in various areas such as Information and Communication Technology, Entrepreneurship, and other Teaching learning areas.

- e) To provide the enhanced research opportunities for the faculty members and researchers of GGSIPU
- f) To encourage the intervention of Information Technology for collaborating on the development of Virtual Platforms.
- g) To mutually develop the learning modules on value-added programmes/ skill enrichment programmes for students and conducting short-term certificates/diploma courses.

Section-3.0: Duration, Revision and Termination of Engagement:


This MOU will be valid for 5 years from the date of signing. Once the initial period of 5 years is over, the MOU shall stand automatically extended for a further period of 5 years, with suitable changes (if required) with mutual consent. If for any reason, any one entity of the MOU is desirous not to continue with the engagement, the same can be done by giving advance notice of two months.

Section-4.0: General Provisions

- a) Any specific joint projects with legally and / or financially binding obligations will be set forth through separate written agreements.
- b) Treatment of intellectual property rights developed through collaborations under this MoU will be determined between the parties through mutual consultation on case to case-to- case basis. In any case, the support of both the partnering institutions shall be duly acknowledged for all academic products having IPR value.
- c) All activities conducted under this MoU will be in accordance with the applicable rules and regulations of the home and host institutions, and all the applicable federal, state and local laws, rules and regulations of the concerned countries.
- d) Nodal Officers shall be nominated by both the parties for execution and forging ties outlined in this MoU.

Section- 5.0: Confidentiality

Each party shall treat as confidential and shall not be disclose to any person/ organisation the terms of this MoU or any information on material supplied or made available in connection herewith without the other party provided, however the party may disclose such information as required by the law of land. The provision shall survive termination or expiration of this MoU.











Section- 6.0: Dispute & Redressal:

That this MOU signed between the parties shall cease to exist after mutual agreement between both the parties at any point of time (within its validity period). However, both parties have the responsibilities for completing the undertaken activities launched as per this MoU.

Any dispute (s) arising out of or in connection with this MoU shall be resolved amicably between the authorized signatories of both the parties.
