

## Memorandum of Understanding (MoU)

Ch. Ramesh Chand Charitable Trust (CRCCT)

This Memorandum of Understanding is executed at **University of Ladakh, Leh, Ladakh UT** on **09.09.2024** (herein after called MoU), **between University of Ladakh** having its office at Leh 194101, UT Ladakh represented by Registrar, University of Ladakh here in after referred to as **UoL** which term and expression shall mean and include, unless repugnant to the context, its successors, assignees, administrators of the **First Party (authorized to sign the MoU's as per delegation)**.

and

**Ch. Ramesh Chand Charitable Trust (CRCCT)** represented by **Sh. Sanjeev Kumar, CEO, CRCCT**, which term and expression shall mean and include, unless repugnant to the context, its successors, assignees, administrators of the Second Party. **Ch. Ramesh Chand Charitable Trust** is a Trust having its Registered Office at **Village-Mirpur Hindu, Near Tronica City, Post Office-Mandaula, Distt. Ghaziabad (U.P.)-201 102** hereinafter referred to as **"CRCCT"** (which expression shall unless repugnant to the context or meaning thereof includes its successor and assignees).

1. All the parties mentioned above shall be referred to singly as **"Party"** and jointly as **"Parties"** under this MoU.
2. **Purpose of MoU– Green University Campus and Youth Development of Ladakh Region.**

Greening of University Campus in Leh in which irrigation facilities will be developed and mass plantation will be done in University area. CRCCT will assist to Ladakh University in the development of greenery and youth development programs in Ladakh Region.

Whereas

In order to implement the "Green Ladakh University Campus" funded by Public Sector Units (PSUs), Multinational Companies (MNCs), private companies in India under Corporate Social Responsibility (CSR) activities. CRCCT will work as Project Implementation Partner subject for the projects developed jointly by parties to the terms and conditions here under:

- A. "Central Govt. Schemes and CSR Programs" on Mass Plantation, Skill Development, Women development, Youth Development, Environmental safety, etc., will be implemented in the University of Ladakh as per need of the University of Ladakh.
- B. CRCCT in coordination with UoL as a part of its commitment towards "Central Govt./State Govt. Schemes and CSR Programs" has been agreed to implement programs developed jointly by both the parties.
- C. The CRCCT has agreed to provide their resources for the benefit of persons to equip the trainees for placing all of them in Wage employment /Self-employment on the basis of the requirements of the local market conditions. The parties mutually agreed to terms and conditions recorded here under.

## ARTICLE – I

### 1. OBLIGATIONS OF THE PARTIES

#### 1.1 CRCCT agrees to implement the joint programs, and shall: -

1. Ensure the compliance of all the terms & conditions as stipulated under the Letter of Intent (LOI) issued by funding agency.
2. Identify and mobilize the number of beneficiaries to be trained as per the eligibility defined by the concerned job role submit to University of Ladakh, Leh.
3. Physical and financial periodic progress reports and upon completion of the project from the closing of the accounting year, its status reports, all financial statements and the pertinent Utilization Certificates of the funds released under the joint programme.

#### 1.2 University of Ladakh, Leh agrees to undertake the followings:

University of Ladakh, Leh will certify/assess all enrolled candidates trained by CRCC Trust after training after fulfilling necessary requirements.

## ARTICLE - II

### FINANCIAL OUTLAY AND DISBURSEMENT:

The total amount for implementing the jointly developed project under various schemes will be released by Funding Agency to University of Ladakh (UoL). University of Ladakh will open a separate bank account for each project and any interest accrued on the amount will be used as per guidelines of the funding agency.

## ARTICLE – III

### CONFIDENTIALITY

All parties acknowledge the confidentiality of information that may exchange among the parties from time to time, under this MoU. All parties agree not to disclose the same to any outside party, unless such information is: Part of the public domain at the time of disclosure or require to be disclosed in accordance with the applicable laws of the country.

## ARTICLE –IV

### ARBITRATION AND APPLICATION LAWS

- 4.1 The parties hereby agree that any controversy, claim or dispute arising in connection with this MoU, and which cannot be resolved amicably shall be referred to the Steering Committee of University of Ladakh.

4.2 In case an aggrieved party seeks judicial remedy, and where University of Ladakh is the First Deponent, the petition shall be filed in court jurisdiction of Ladakh UT.

**ARTICLE - V  
FORCE MAJEURE**

No failure or omission by any of the parties to perform any of the terms and conditions under this MoU shall give rise to any claim against such party or be deemed breach of this MoU if such failure or omission arises from an act of God, war or military operations, national or local emergency, natural disasters (fire, lightning, flood, earthquake or such similar disasters), or any other reason which lies outside the control of the Parties.

**ARTICLE - VI**

**1. VALIDITY OF THE MOU**

This MoU shall come into force on 09.09.2024 and shall be valid for the 3 years from the date of signing of MoU or till completion of the running projects executed during the tenure of this MoU.
